Dear Customers,

We have decided to temporarily close our Yonge Street Branch for an extended period in order to allow improvements to be made to the branch, in an effort to better serve our customers. Accordingly, please see the information below relative to such closure.

## 1. Affected Branch

Please note that there is no action required of you at this time. There will be no interruption in service and you will continue to have access to your accounts with no change to your account numbers and related banking information.

Further, during the period that the branch will be closed, customers will continue to have access to our automated banking machine located at the branch during our usual and customary business hours, being between: 10:00-17:00 on business days. You will also continue to have access to your safety deposit boxes located at the branch. This access will be facilitated by a bank representative who will be physically present at the branch during the business hours indicated above.

# 4. Financial Consumer Agency of Canada ("FCAC")

In compliance with the requirements of the FCAC and for the purposes of our temporary branch closure, the following information is being provided to you.

The Commissioner of the FCAC may require Industrial and Commercial Bank of China (Canada) to convene and hold a meeting between representatives of Industrial and Commercial Bank of China (Canada), representatives of the FCAC and interested parties in the vicinity of the branch, in order to exchange views about the proposed closure of the branch if:

- Industrial and Commercial Bank of China (Canada) has not consulted the community in the area affected by the closure of the branch well enough to ascertain the views of interested persons in the community with regard to the closure of the branch,
- an individual or a community representative from the area affected by the closure of the branch submits to the Commissioner a written request for the meeting, and
- the request is not frivolous or vexatious
